Every Board Member must:

1. Make a reasonable time commitment to be dedicated to the HSTGC every month.
2. Sit on a committee, "own" a project, or hold an office of the HSTGC.
3. Physically attend one HSTGC event each quarter.

Board meetings are held monthly on a "To Be Announced" schedule, beginning at 6:00 pm. They are held at the Humane Society's office INSIDE the City Animal Shelter.

According to our by-laws, missing three regular (monthly) meetings without valid reasons (illness-family/job emergency) during a calendar year will result in cessation of service.

Each board term is a 3-year term. At the end of that term, member may either resign from the board or serve another 3-year term (if recommended by the Nominating Committee).
