Memorandum of Understanding

This agreement is between the Tom Green County Humane Society, hereinafter "the HS", and the guardian of the following animal, hereinafter "guardian" and "pet."

Purpose of the Second Chance Program:

To assist the pet's guardian in finding a new home for the pet in the event that the guardian is unable to keep and care for the pet so as to avoid the pet's relinquishment to the City Animal Shelter and possible euthanasia.

Terms of the agreement:

Guardian understands that the HS will attempt to re-home the pet by any means at its discretion, including, but not limited to: internet listing, local classified advertising, word of mouth, or contact with breed-specific rescue groups.

The HS is not offering to take the pet into its care, unless specifically stated herein.

The guardian agrees to keep and care for the pet as long as necessary to find a new home for the pet.

In the event that the guardian finds an appropriate home for the pet separately from the HS's efforts, the guardian agrees to notify the HS immediately so that the HS may remove all advertising of the pet.

The guardian agrees to have the pet spayed or neutered at his or her own expense, and the guardian agrees that the pet will be current on all required vaccinations and in reasonably good health.

In the event a prospective adopter is found, the guardian agrees to transport the pet to the San Angelo Animal Shelter at 3142 U.S. Highway 67 North, San Angelo, Texas, during business hours, so that the potential adopter may meet the pet.

The guardian reserves the right to refuse the adoption of its pet by any party, but the HS may cancel the guardian's participation in this program.

Either the HS or the guardian may terminate this agreement at any time upon written notice to the other party, at which point neither party is further bound by the terms of this agreement.

I understand and agree to all terms as stated herein. I understand that the Humane Society of Tom Green County is offering to assist me in re-homing my pet in the interest of avoiding the animal's surrender at the city animal shelter, and that the Humane Society is in no way guaranteeing that my animal will be adopted. I also understand that the Humane Society may terminate this agreement and refuse further assistance at their sole discretion.

I understand the term as set forth herein, and I agree to them.
